i- Classroom and school resources system
 School-based discipline management system - *Consequences*

<u>Offense</u>	<u>Plan of action</u>	<u>Explanation</u>
First	Try again	Some first offenses that may require immediate suspension: i.e., fighting, possession of a weapon, etc.
Second	Alternative Classroom Detention	..in a supervised area other than the rest outside the classroom, and the main office. Denial of extra-curricular activities. Like After School Sport and Running Team
Third	Think Sheet to parent by student	parent must acknowledge phone call before student can return to class.
Fourth	parent-teacher conference School-Home Behavior Plan	Arranged at a time of mutual agreement between parent & teacher.
Fifth	Conference	principal, teacher, and parent (to consider options: suspension, expulsion, alternative placement, etc.

Discipline management

Although we do not expect children to sit perfectly still and quiet all day, there are rules the children must follow to ensure a maximum learning climate in the classroom and throughout the school. Our Principles of Discipline are as follows:

1. Respect: Treat everyone with courtesy and respect.
2. Safety: Act in a safe and positive way.
3. Preparedness: Come to school prepared for learning.
4. Responsibility: Act responsibly in and out of the school building.
5. Focus: Stay on task.

Although we prefer to accentuate the positive, there are times when consequences for inappropriate behavior are necessary. Not adhering to the Principles of Discipline will result in the following consequences:

1. Verbal warnings, along with redirecting the situation, will first be given. Time out will then be given for inappropriate behavior.
2. First infraction: The Student will be sent to alternative classroom
3. Second infraction: The student will not have the privilege to participate in Friday Sale
4. Third infraction: The student will not participate in field trips
- 5- Fourth infraction: The student will not attend 5-8 Graduation trip
6. If behavior continues over a period of time, the child will be sent to the front office and a discipline notice will be sent home.
7. If behavior continues DRAW ACADEMY Discipline Policies will be applied.

Conduct rewards

<u>Time frame</u>	<u>Reward</u>
Excellent conduct for the week	The student have a chance to participate in Friday Drawing
Excellent conduct for the month (school wide)	The student will participate in Monthly PBIS Party
Excellent conduct for the grading Period (school wide)	certificate special activity or treat (a list will be prepared for each grading period)
Excellent conduct for the semester	The student will be \$20 Barnes and Nobles Gift Card (Transportation to Barnes and Nobles will be provided DRAW Academy)
Consistent & exemplary behavior (school wide)	No uniform for the last two weeks of school

ii- Vandalism / graffiti discipline action.

Parents will be offered the following alternative if their children defaces property.

Due the nature of the act and in lieu of contacting the Houston Police Department the school offers the following contract.

- The student will serve 10 days of in-school detention.
- The student will complete all assignments by the teacher during his/her detention time. If the student fails to complete the 100% of the assignments she/he will serve one extra day of detention for each incomplete assignment day.
- The student will serve five days of three hours of community service each day, helping to clean and repairing the damage during the after-school time from 3:15 to 6:15 pm on days to be arranged.
- The student must write a letter of apology to the administration and to the students. This letter must be accepted by the school principal and must be read in front of his/her class.
- The Student must pay \$50 for repair materials.
- If the student fails to complete this contract the school will contact the Houston Police Department to report the act of vandalism and the school attorney will start court procedures.
